Future Commission dates for 2015:

- Wednesday, May 13, 2015 was previously confirmed as a spring meeting date
- August 22, 2015 is the date of the Iowa Women's Hall of Fame ceremony
- In recent years, a fall meeting was scheduled in early to mid-November

2015 Iowa Women's Hall of Fame:

- Nomination deadline: April 1, 2015
- Selection committee will meet in April and the recommendations for 2015 honorees will be submitted for Commission approval in May
- Hall of Fame selection committee is to include the following: Three (3) commissioners as active members; Commission chair as ex-officio; and two (2) members from the public
